



## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.bernau-design.com](http://www.bernau-design.com) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Bernau Design include [www.bernau-design.com](http://www.bernau-design.com) and Bernau Design. ## **Collection of your Personal Information**

In order to better provide you with products and services offered, Bernau Design may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address

Bernau Design may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. We also may gather additional personal or non-personal information in the future.

## **Use of your Personal Information**

Bernau Design collects and uses your personal information to operate and deliver the services you have requested.

Bernau Design also use your personally identifiable information to inform you of other products or services available from Bernau Design and its affiliates.

## **Sharing Information with Third Parties**

Bernau Design does not sell, rent, or lease its customer lists to third parties.

Bernau Design may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited

from using your personal information except to provide these services to Bernau Design, and they are required to maintain the confidentiality of your information.

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent; Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
